Mission

NJDEP Emergency Management consists of programs committed **24/7/365** to ensure the safety of the people of New Jersey and protect the environment during **all-hazard** emergency situations by supporting the network of NJDEP responders and working closely with federal, state, county, and local partners.

Responsibilities

- **Function as the NJDEP's Emergency Management Coordinator and primary point of contact for NJESF-3 and NJESF-10** to the New Jersey Office of Emergency Management (NJOEM) and other agencies (county, state, and federal) for all threats and hazards.
- **Coordinate the NJDEP's internal network of program-level Emergency Response Coordinators** to provide subject matter expertise when needed.
- **Oversee the NJDEP Communications Center**, which handles the intake and referral for the DEP Hotline, as well as the radio dispatch and support for NJDEP law enforcement and other program users.
- **Deploy field responders (boots-on-the-ground)** to assess and remediate incidents that impact public health and the environment; provide state-level on scene coordination for all-hazard emergencies.
- **Coordinate planning, response, and recovery activities** for the NJDEP at the State Emergency Operations Center, NJDEP Emergency Operations Center, and Federal Joint Field Office.

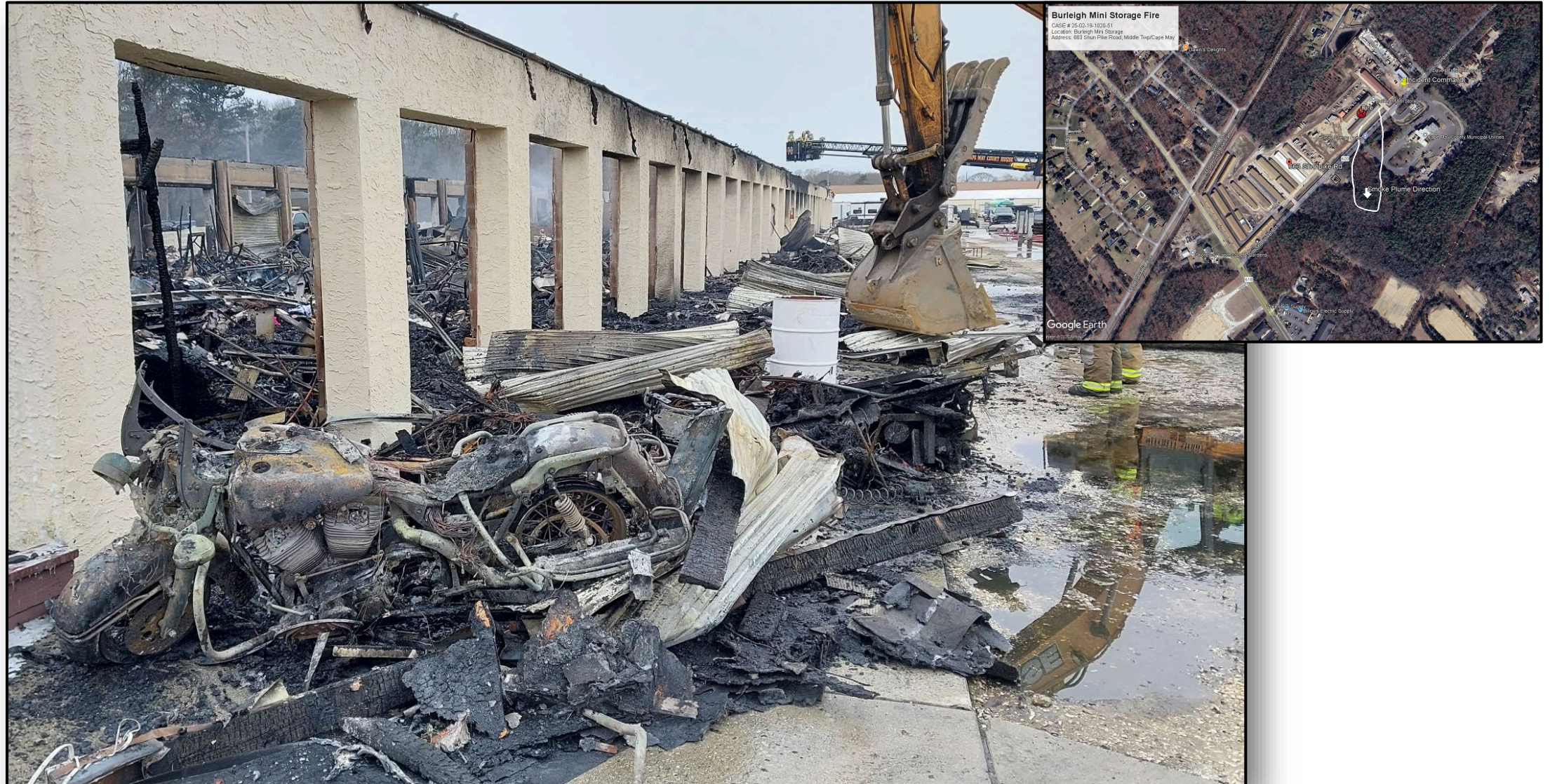

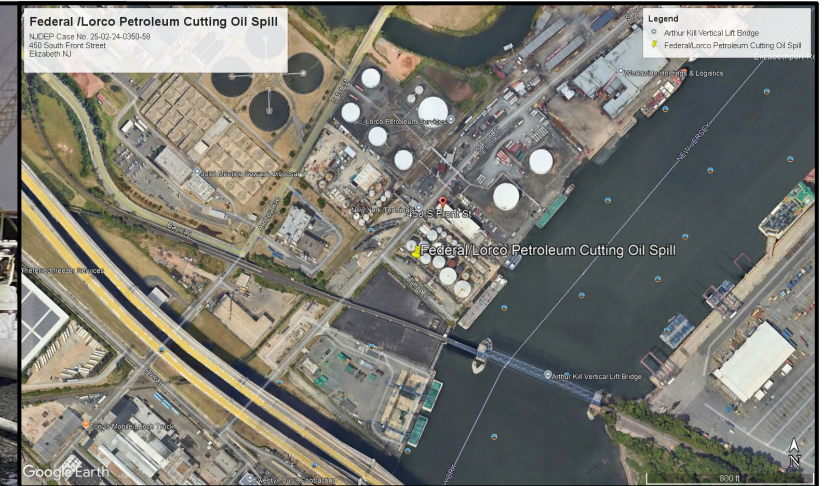

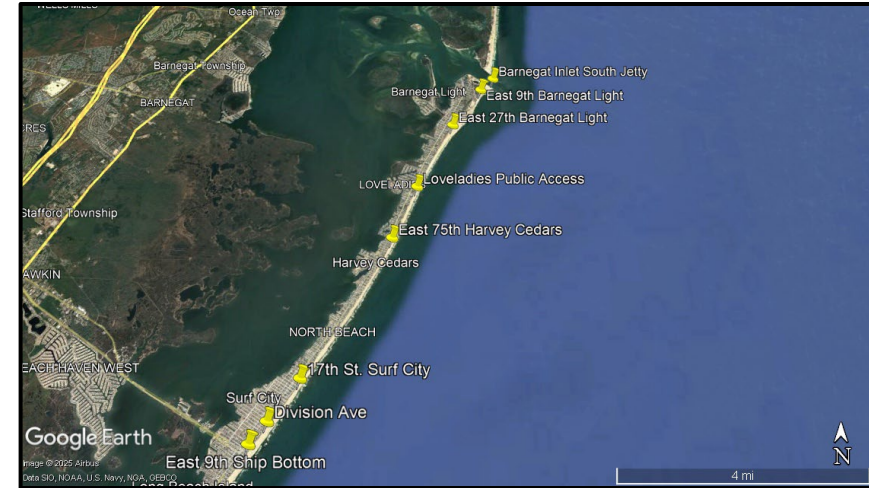
