IMAT Workshop 2025

- 3 Day workshop lead by the USCG National Strike Force's Incident Management Assist Team
- Over 40 participants including Sector New York Active Duty, Reservists, and Civilians and District 1 Public Affairs Detachment
- Serious Marine Incident Scenario
- Training consisted of one-on-one position specific training with IMAT instructors, Incident Action Plan development, and full implementation/rotation of the Incident Command System's "Planning P".







AMSTEP 2025 – OP AMBROSE SWEEP

- 3 Phase Exercise
- On Water Field Activity (Diving Operations/Sonar/ROV)
- Incident Notifications- CIC/NCC/NRC/MOTR
- Stand Up of Unified Command & Incident Command Post
- More than 200 Federal, State, local and private industry partners: SNY Active Duty, Reserve and Civilians, STA SH, ANT Bayonne, USN, FBI ,CBP, HIS, NYPD, NJSP, NYSP, FDNY, NOAA,NYCEM,NYSDHES,NJOHS, AT&T FIRSTNET, Navy Militia
- Achieved validation of critical maritime security response capabilities including the Integrated Unified Port Assessment, vessel quarantine and inspection procedures, MARSEC escalation, port closure protocols, and Marine Transportation System Recovery Unit planning and activation.

EVELYN CUTLER 19 FEB 2025







- Sector NY received a report of a discharge of **1000 GALs** of diesel fuel into the Arthur Kill.
- ERIs conducted a first-light assessment and verified discharge volumes and response efforts.
- Initial on-scene investigations led to subsequent NOV enforcement actions.
- Atlantic Response utilized boom and finalized clean up at 1600.

Imperial Yacht Club – New Rochelle 22 FEB 2025





- Sector NY received a report from
 Westchester FD of approximately four
 active recreational vessels on fire and
 two smoke inhalation victims.
- IMD ERIs initial assessment reported five total vessels catching fire and sinking.
- Response and salvage operations were monitored throughout the incident lasting a total of six days.

Helicopter Crash – Hudson River 10 APR 2025



- Initial report of a helicopter crash in the Hudson River was received by Sector NY with accountability unknown and five personnel recovered.
- Salvage operations conducted by ACOE vessel DRIFTMASTER with minimal pollution reported.
- Bell-206L-4 Long Ranger
 IV helicopter had a fuel capacity of
 112 GALs and 1.5 GALs of engine oil.

T/S CUAUHTEMOC Allision – Brooklyn Bridge 17 MAY 2025



- Sector NY received a report of an allision of the T/S CUAUHTEMOC with the Brooklyn Bridge
- No reports of pollution in the area were received.
- On-scene tugs successfully relocated the ship where further investigation and inspection of the vessel can be completed.

T/B HUNTS POINT – Hudson River 24 MAY 2025





- An explosion occurred onboard the T/B HUNTS POINT resulting in a death and two injured crewmembers.
- On-scene reports from STA NY, and NYPD drone assessment reported no pollution in waterway.
- ERIs on-scene confirm no threat of pollution.
- Incident resulted in COTP order and transfer of vessel to Brooklyn Navy Yard.
